## May 12, 2018 - Special Meeting Minutes

### 1. Call to Order

Candidate #38 completed the oral interview process after which the candidate was dismissed from the proceedings. The Commissioners deliberated on the candidate's oral interview performance. Chairman Kovanda made a motion to advance the candidate to the polygraph phase of the hiring process. Commissioner Musial 2nd the motion. Vote: Yes - 2, No - 1 Motion does not carry. The candidate will be informed of the Board's decision.

Candidate #39 completed the oral interview process after which the candidate was dismissed from the proceedings. The Commissioners deliberated on the candidate's oral interview performance.
